Meeting was called to order by Chair Davis Kohl. Vice Chair Tilley and Commissioners Welch, Merchant, and Majewski were in attendance along with Board Counsel Amy K. Finneran and General Manager Scott Baker.

AUDIT PRESENTATION

Ms. Dojan indicated that this is typically known as a clean audit opinion, and it's the highest level of assurance that an accounting firm can provide.

Motion was made by Commissioner Merchant and seconded by Vice Chair Tilley to approve the license; the vote was unanimous.

Motion was made by Commissioner Majewski and seconded by Commissioner Welch to approve the license if proper non-profit status documentation is submitted before close of business 10/11/2019; the vote was unanimous.

1) P.J.C., Inc., T/A Ice House Liquors

Due to a miscommunication with licensee's counsel, this hearing has been rescheduled to 11/06/2019.

2) Chile Enterprises, Inc. T/A La Tolteca (Aberdeen)

David Carrillo, President, Chile Enterprises, Inc. T/A La Tolteca, 984 Hospitality Way, Aberdeen, MD 21001 appeared in proper person in connection with a show cause hearing indicating violation of:

A) Failure to have a supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold, in violation of AB § 22-1903 and Board Rule 3:14. It was alleged this violation occurred on May 31, 2019.

- A) Motion was made by Commissioner Welch and seconded by Commissioner Majewski to find License Holder in violation of AB § 22-1903 and Board Rule 3:14 (failure to have a supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold) for the violation on 05/31/2019; the vote was unanimous. Motion was made by Vice Chair Tilley and seconded by Commissioner Welch to impose a fine of \$500.00 for the above violation; the vote was unanimous.
- B) Motion was made by Commissioner Welch and seconded by Vice Chair Tilley to find License Holder in violation of Board Rule 2:32 (All named license holders must appear at the time of the hearing for any violation or discussion as directed by the

Board, unless previously excused), having occurred on 10/09/2019. Motion was made by Commissioner Merchant and seconded by Vice Chair Tilley to impose a fine of \$250.00; the vote was unanimous.

- A) Motion was made by Commissioner Majewski and seconded by Commissioner Welch to find License Holder in violation of AB § 22-1903 and Board Rule 3:14 (failure to have a supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold) for the violation on 09/05/2019; the vote was unanimous. Motion was made by Commissioner Welch and seconded by Commissioner Merchant to impose a fine of \$500.00 for the above violation; the vote was unanimous.
- B) Motion was made by Commissioner Merchant and seconded by Commissioner Welch to find License Holder **in violation** of Board Rule 2:32 (All named license holders must appear at the time of the hearing for any violation or discussion as directed by the Board, unless previously excused), having occurred on 10/09/2019. Motion was made by Commissioner Welch and seconded by Commissioner Welch to impose a fine of \$250.00; the vote was unanimous.
