STAFF REPORT / PUBLIC COMMENT / BOARD COMMENT

Mrs. Baxter confirmed that the Commissioners have received the fourth draft of the audit for review. It was determined that "Personnel" would include payroll/payroll taxes, pension, and benefits. Once the Commissioners have approved the audit, the representation letter will need to be signed. Mrs. Baxter will request that the auditor reschedule his presentation to Thursday, August 17. Page 25 of the audit discusses the disposition of license fees. The budget is near completion.

License holder Michael Scheuerman of Friendship Wine & Liquor stated that his business has been the victim of shoplifting by minors on several occasions and the Sheriff's Office has been notified.

Daniel Buchler has been hired as the part-time Inspector and Chief Inspector Colburn's last day is August 9.

Contingent on written verification from license holder's counsel, the Commissioners agreed that it will be acceptable for Inspector Buchler to read the Chief Inspector's violation report into the record for the August 23 show cause hearing.

There being no further business, motion was made by Commissioner Majewski to adjourn the meeting and was seconded; the vote was unanimous.
