First-time applicants M. Rebecca Flickinger and Richard Mahoney appeared on behalf of Tidewater Players in connection with a per diem application for beer, wine and liquor to be used on February 23, 24 and 25 and March 1, 2 (two shows), and 3 at the Havre de Grace Opera House for the play "Margaritaville". Motion was made by Commissioner Walters and was seconded to approve the application; the vote was unanimous. (A refund of \$30 was later issued to the organization as they paid two license fees for March 2 and were only required to pay one license fee.)

2) <u>Matthew's L3 Pizzeria, L.L.C., T/A Matthew's L3 Pizzeria – New License (Tentative Approval)</u> Christopher Maler, Member, Henry Tiburzi, Member, Matthew's L3 Pizzeria, L.L.C., T/A Matthew's L3 Pizzeria, 1517 Rock Spring Road (Suite B), Forest Hill appeared in connection with tentative approval of an Application for a New License for a Class B1-BW-On Sale Only License. Interest in the L.L.C. is held as follows: Mr. Maler, 50%; Mr. Tiburzi, 50%. Mr. Maler will serve as the responsible operator. Mr. Maler amended his response to #13b on page 3 of the application to be "no". Chair Goddard disclosed that he has had past business dealings with applicants. Motion was made by Vice Chair Burdette and was seconded to approve the application; the vote was unanimous.

1) B & S, L.L.C. T/A Looney's Pub North - Outside Event Application

Joseph F. Snee, Jr., Esquire, appeared on behalf of B & S, L.L.C. T/A Looney's Pub North, 312 South Main Street, Bel Air in connection with an Outside Event Application to be used on March 16 and 17 for their annual St. Patrick's Day Celebration. After review of the application, motion was made by Commissioner Majewski and was seconded to approve the application; the vote was unanimous.

SHOW CAUSE HEARING

Longobardi, L.L.C. T/A Garibaldi's Italian Pizza & Grill (AA)

Roberto Longobardi, Member, Longobardi, L.L.C. T/A Garibaldi's Italian Pizza & Grill, 686 Bel Air Road, Bel Air appeared along with their attorney Stephan W. Fogleman in connection violation of the following:

CHARGE 1: Failure to comply with Alcohol Awareness certification requirement in violation of Md. Code Ann., Alcoholic Beverages Article, Section 4-505(f) and 22-1903 ("Code") and Board Rule 3:14 (a)(c) ("BR).

CHARGE 2: Did fail to keep complete and accurate records of all alcoholic beverages purchased in violation of AB §22-1904, and BR 3:06 which provides that:

- (a) A license holder shall keep complete and accurate books of account of daily receipts, expenditures, and invoices in the form that the Board requires; and procure vouchers or purchase slips for all alcoholic beverages, food, and other items bought for sale ("Records").
- (b) For purposes of this section, the Records required under paragraph (a) shall include either hard copy or digital Records in a downloadable format.
- (c) A license holder shall keep such Records for a period of two years from the date of each purchase, which shall include the following:
 - (1) The date of each purchase;
 - (2) The quantity purchased; and
 - (3) The name and address of each seller.

(d) All Records shall be kept open to inspection at all times by the Board or a designee of the Board. The license holder shall continue to retain Records for any alcoholic beverages that remain on the premises after the initial two-year period. Records will be checked semi-annually.

CHARGE 3: Did fail to keep on the licensed premises all records containing legal names, aliases, addresses, dates of birth, and legible photocopy of government-issued identification of all persons employed by them. Such records shall be open for inspection at all times by a designee of the Board, any police agency of Harford County, and any other governmental agency in violation of Md. Code Ann., Alcoholic Beverages Article, Section 22-904 ("Code") and Board Rule 3:06 ("BR").

The alleged violations occurred on December 12, 2023.

Subsequent to the hearing, the Board considered all the evidence presented. Based upon the statement of facts (i.e., the written report of Chief Inspector Buchler), as well as applicable License Holder's testimony and with further consideration to License Holder's relevant past record (if any), the Board made the following findings:

On Charge 1, motion was made by Commissioner Walters and was seconded to find License Holder in violation; the vote was unanimous. Motion was made by Commissioner Sines and was seconded to impose a fine of \$100.00; the vote was unanimous.

On Charge 2, motion was made by Commissioner Majewski and was seconded to find License Holder in violation of paragraph (d). Roll call vote was taken: Vice Chair Burdette "yes"; Commissioner Majewski "yes"; Commissioner Sines "no"; Commissioner Walters "no"; Chair Goddard "no". The violation was not sustained.

On Charge 3, no motion was made thus the violation was not sustained.

2) Longobardi, L.L.C. T/A Garibaldi's Italian Pizza & Grill (Underage Sale)

Roberto Longobardi, Member, Longobardi, L.L.C. T/A Garibaldi's Italian Pizza & Grill, 686 Bel Air Road, Bel Air appeared along with their attorney Stephan W. Fogleman in connection violation of the following:

CHARGE 1: Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of Md. Code Ann., Alcoholic Beverages Article, Section 6-304 ("Code") and Board Rule 4:01.

The alleged violation occurred on December 18, 2023.

Subsequent to the hearing, the Board considered all the evidence presented. Based upon the statement of facts (i.e., the written report of Chief Inspector Buchler), as well as applicable License Holder's testimony and with further consideration to License Holder's relevant past record (if any), the Board made the following findings:

On Charge 1, motion was made by Commissioner Walters and was seconded to find License Holder in violation; the vote was unanimous. Motion was made by Commissioner Majewski and was seconded to impose a fine of \$1,200.00; the vote was unanimous.

John Kosmakos, Ciro Coppola, Gennaro DiBenedetto, Steven Diddlemeyer, Bacco Pizzeria, L.L.C., T/A Bacco Pizzeria, 3468-70 Emmorton Road, Abindon appeared in proper person in connection with violation of the following:

CHARGE 1: Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of Md. Code Ann., Alcoholic Beverages Article, Section 6-304 ("Code") and Board Rule 4:01.

The alleged violation occurred on December 18, 2023.

On Charge 1, motion was made by Commissioner Walters and was seconded to find License Holder in violation; the vote was unanimous. Motion was made by Commissioner Majewski and was seconded to impose a fine of \$1,200.00; the vote was unanimous.

CHARGE 1: Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of Md. Code Ann., Alcoholic Beverages Article, Section 6-304 ("Code") and Board Rule 4:01.
