

## RENEWAL APPLICATION INSTRUCTIONS 2018-2019 ALCOHOLIC BEVERAGE LICENSE

---

- Renewal applications for the Licensing Year beginning May 1, 2018, are available **ONLINE** at [www.hclcb.org](http://www.hclcb.org) beginning **February 1, 2018**.
- Paper copies of the Renewal Packet will be provided by **REQUEST ONLY**; please contact the Board Office for further information.
- Completed Renewal Applications must be filed by **March 15, 2018**, with a renewal processing fee of **\$45.00**. Only Cash or Checks (made payable to Harford County Liquor Control Board) will be accepted.
- **Keep in mind...** applications must be **complete, notarized, and signed by all named applicants and property owner** to be accepted and/or approved.
- The Board Office is open Monday through Friday, from 8:30am to 4:30pm. You are encouraged to bring the application in person. **If mailed, make sure it is received in the Board Office before March 15, 2018.**
- You may pay your **Annual License Fee** at the same time; however, it must be submitted by **SEPARATE CHECK**. Licenses paid for in advance will be delivered to the licensed premises prior to April 30, 2018.
- Applications received **after March 15, 2018**, will be charged a **\$200.00 renewal processing fee**. Please file your application early to avoid the late fee.
- Applications submitted **after April 2, 2018**, will be **held by the Board for a period of 30 days before further action is taken and will result in the License Holder being unable to serve or sell alcoholic beverages for the time between the expiration of the prior license and the approved effective date of the Renewal License.**
- Tax Clearances from Harford County (**Revenue Collections @ 410-638-3269 (Ext. 1326)**) and the State of Maryland (**Comptroller's Office @ 410-767-1630**) must be **received by April 30, 2018**, regardless of whether your Renewal Fee and/or License Fee are paid. **Licenses will not be released** without approval from both tax agencies. You must have a valid license to make sales.
- Your business must be in **Good Standing** with the State. To check the status, contact the **State of Maryland at 410-767-1330** or online at [www.dat.state.md.us](http://www.dat.state.md.us). **Keep in mind**, your Renewal Application must be submitted by the **March 15, 2018, deadline; and all outstanding tax issues, good standing, etc., must be satisfactorily resolved by April 30, 2018.**
- You are required to have both a valid **Worker's Compensation Insurance ("WCI") Certificate** and valid **Alcohol Awareness Training ("AAT") Certificates** on file with the Board Office. Please include a copy of your WCI certificate and your completed AAT form (mailed to you in January 2018) with your Renewal application.

### LICENSES WILL BE READY APRIL 23, 2018

LICENSES MAY BE PICKED UP AT THE BOARD OFFICE BETWEEN  
MONDAY, **APRIL 23, 2018**, AND MONDAY, **APRIL 30, 2018**.  
PAYMENT OF LICENSE FEE IS REQUIRED TO PICK UP YOUR LICENSE.

### RENEWAL APPLICATION DEADLINES

- ✓ **Thursday, March 15, 2018:** Last day to submit the Renewal Application without incurring late fees
- ✓ **Monday, April 2, 2018:** Last day to file Renewal Application
- ✓ **Monday, April 30, 2018:** Last day to pay for & pick up the 2018-2019 Alcohol License
- ✓ **Tuesday, May 1, 2018:** State Law requires the 2018-2019 Alcohol License be posted at your facility when you open for business.
