Four Supplemental Applications pending approval today (Events Catering Company, Black Forest Tap House, Bulle Rock Gourmet Pub & Grill, Aberdeen Memorial Post 10028), which can now be released.

Three licenses have not been released (Sizzling Bombay, Venetian Palace, and Otter Point Yacht Club).

A timeline of communication with Otter Point Yacht Club was presented. The 2020-2021 License Renewal was not finalized due to an outstanding supplemental and a state tax hold. The supplemental was filed in September 2020 (following new club elections) and scheduled for presentation to the Board on 10/26/20, but was postponed as none of the outstanding items have were resolved. To date, despite several conversations and numerous other attempts to contact license holders, the supplemental application filed in September 2020 remains unresolved, and a 2021-2022 Renewal application was never filed. The club continues to operate on their 2019-2020 license. Mrs. Finneran will review the timeline and Executive Orders from the Governor to determine if a certified letter allowing license holders five business days to resolve outstanding items would be appropriate.
