Motion was made and seconded to approve this Application; the vote was unanimous.

#### 1) Mint 1, Inc., T/A The Mint Room

Shailja Anand, President, Rayshad Beepath, Assistant Secretary, Mint 1, Inc. t/a The Mint Room, 528 Baltimore Pike, Bel Air, appeared along with their attorney, Joseph F. Snee, Jr., in connection with a show cause hearing indicating violation of:

1) Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01.

The Violation occurred on October 27, 2021.

Subsequent to the Hearing, the Board considered all the evidence presented. Based upon the statement of facts (<u>i.e.</u>, the written report of Board Inspector William Colburn), as well as applicable License Holders' testimony, and with further consideration to License Holders' relevant past record (if any) motion was made and duly seconded to find License Holders **in violation** of Charge (1) Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01; the vote was unanimous. Motion was made and seconded to impose a fine of \$1,500.00; the vote was unanimous.

# 2) Mexican Food II, Inc. t/a La Tolteca

David Carrillo, President, Mexican Food II, Inc. t/a La Tolteca, 1411 S. Mountain Road, Joppa, appeared in proper person in connection with a show cause hearing indicating violation of:

1) Failure of Resident Licensee / Responsible Operator to be physically present on the premises a substantial amount of time on a daily basis, in violation of the Alcoholic Beverages Article (AB) § 22-1405(a) of the Annotated Code of Maryland, and Board Rule 2:06(c)(6).

The Violation is alleged to have occurred on numerous occasions between September 5, 2019, and January 10, 2022, as documented in the enclosed Violation Report.

License Holder Dayana Ortiz Viernes did not appear at the hearing.

Subsequent to the Hearing, the Board considered all the evidence presented. Based upon the statement of facts (<u>i.e.</u>, the written report of Board Inspector William Colburn), as well as applicable License Holders' testimony, and with further consideration to License Holders' relevant past record (if any) motion was made and duly seconded to find License Holders **in violation** of Charge (1) Failure of Resident Licensee / Responsible Operator to be physically present on the premises a substantial amount of time on a daily basis, in violation of the Alcoholic Beverages Article (AB) § 22-1405(a) of the Annotated Code of Maryland, and Board Rule 2:06(c)(6); the vote was unanimous.

Motion was made and seconded to impose a three (3) day suspension; the vote was unanimous. License Holder David Carrillo agreed to forgo the thirty (30) day appeal period, electing instead to serve the suspension on February 28, March 1, and March 2, without the possibility of appeal; the vote was unanimous.

Motion was made and duly seconded to impose a fine of \$250.00 for failure of License Holder Dayana Ortiz Viernes to appear for the hearing; the vote was unanimous.

# 1) JVille Foodies, L.L.C. T/A JVille Grille – Request for Extension

Ryan Cooper, Member, appeared before the Board in proper person to request an extension of time frame for settlement.
