CALL MEETING TO ORDER

Meeting was called to order by Vice Chair Majewski. In attendance were Commissioners Welch, Merchant and Burdette along with Board Counsel Amy K. Finneran and Judith Powell. Wayne Goddard was introduced and welcomed as the newly appointed Commissioner.

REORGANIZATION OF THE BOARD

Commissioner Welch nominated and moved to appoint Paul J. Majewski as Chair of the Board; Commissioner Burdette seconded the motion; the vote was unanimous. Commissioner Welch also nominated and moved to appoint Frederic L. Merchant as the Vice Chair; Commissioner Burdette seconded the motion; the vote was unanimous.
