April 13, 2022

#### **CALL MEETING TO ORDER**

Meeting was called to order by Chair Majewski. In attendance were Commissioners Welch, Burdette and Goddard along with Board Counsel Amy K. Finneran and Judith Powell. Vice Chair Merchant was absent.

### PERSONS SCHEDULED TO APPEAR BEFORE THE BOARD

- 1) First-Time Applicants Tabitha's House Per Diem Beer & Wine Application
  First-time applicants Susan Sinclair and Linda Underhill appeared on behalf of Tabitha's House in connection with a per diem beer and wine application for a wine festival to be held at 3520 Woodsdale Road in Abingdon on April 30. Motion was made and seconded to approve the application; the vote was unanimous.
- 2) <u>First-Time Applicant Knights of Columbus Council 2002 Per Diem Beer & Wine Application</u> First-time applicants John Marley and M. Frank Jackson appeared on behalf of Knights of Columbus Council #2002 in connection with a per diem beer and wine application for a fundraising dinner to benefit four area seminarians to be held at St. Joan of Arc church hall on May 7. Motion was made and seconded to approve the application; the vote was unanimous.
- 3) First-Time Applicants Bel Air Downtown Alliance Per Diem Beer, Wine & Liquor Application First-time applicants Shelby Tittle and Emma Knight appeared on behalf of Bel Air Downtown Alliance in connection with a beer, wine and liquor application for First Friday events being held on May 6, June 3, July 1, August 5, September 2, and October 7. Commissioner Goddard disclosed that he was a previous Board member of the Alliance. Motion was made and seconded to approve the application; the vote was unanimous.

4) Get It Done, L.L.C., T/A The Local - Change in Class & Change of Officers

Robert Windsor, Member, Natalie Piccirilli, Member, Get It Done, L.L.C. T/A The Local, 1918 Bel Air Rd., Fallston appeared along with their attorney, Mark E. Shach, in connection with an Application for Change in Class and Change of Officers. The purpose of the application is to make two changes; the first is to change the license class from Class B-Café-BW-On/Off Sale-L On Sale Only License to a Class B-BWL-On Sale Only License. Food sales over the past six months have ranged between 65% and 80% versus the alcoholic beverage sales. The current seating capacity is 74 seats.

The second change is to add Natalie Piccirilli, Member, to the license. Robert Windsor will remain on the license holding 12.5% interest, Ms. Picirilli will hold 10% interest, and the remaining 77.5% is held by Evolved Hospitality, L.L.C. Ms. Piccirilli will serve as the Responsible Operator and has passed the licensee test. Motion was made and seconded to approve the change in class and the change of officers; the vote was unanimous. The two changes will take effect as of May 1, 2022, eliminating the need for a renewal application to be filed.

- 5) <u>Battery Island Brewing Company, L.L.C. T/A Battery Island Brewing Company Change of Officers</u>
- Kyle B. Hurst, Managing Member, Samantha M. Sammons, Member, Battery Island Brewing Company, L.L.C. T/A Battery Island Brewing Company, 101 N. Washington Street, Havre de Grace, appeared in connection with a Change of Officers Transfer Application. The purpose of the application is to remove Kevin M. Wilson from the license and to add Samantha Sammons, Member. Kyle B. Hurst, Managing Member, will remain on the license. Mr. Hurst now holds 90% of the interest in the L.L.C. and Ms. Sammons holds the remaining 10% interest. Samantha Sammons will serve as the Responsible operator and has taken and passed the licensee test. Motion was made and seconded to approve this application; the vote was unanimous.
- 6) Wining Out, L.L.C., T/A Vineyard Wine Bar Supplemental Application
  Joseph Lertch, President, Suzanne Cronin, Treasurer, Angelia Milburn, Secretary, Wining Out, L.L.C. T/A Vineyard Wine Bar, 142 N. Washington Street, Havre de Grace, appeared along with their attorney, Bradley R. Stover, in connection with a Supplemental Application. The purpose of the application is to remove Jarrod Cronin and add Angelia Milburn to the license. Joseph Lertch, President, and Suzanne Cronin, Treasurer, will remain on the license. Mr. Lertch holds 51% of the interest in the L.L.C., Ms. Cronin holds 16%, and Ms. Milburn holds the remaining 33% interest. Mr. Lertch will continue to serve as the responsible operator. Motion was made and seconded to approve this application; the vote was unanimous.
- 7) <u>Harbor Wine & Spirits, L.L.C., T/A Harbor Wine & Spirits New License (Final Approval)</u>
  Ankit P. Desai, Sole Member, Harbor Wine & Spirits, L.L.C., T/A Harbor Wine & Spirits, 1027 and 1029 Pulaski Highway, Havre de Grace, appeared along with their attorney Joseph F. Snee, Jr., in connection with A new Class A1-BWL-Off Sale Only License. The Board issued tentative approval on June 9, 2021; the build-out is complete, and Mr. Desai is seeking final approval. Motion was made and seconded to issue final approval; the vote was unanimous.
- 8) <u>Ish Krupa, L.L.C., T/A Hilton Garden Inn Bel Air Final Approval Hearing (POSTPONED)</u> This hearing has been postponed and is rescheduled for May 4.

9) Logos, Inc., T/A 510 Johnny's - Change of Officers Transfer

loannis Korologos, President, Nicholas Tsirlis, Secretary, and Mohammed Jadoo, Vice President, Logos, Inc. T/A 510 Johnny's, 510 Marketplace Drive, Bel Air, appeared along with their attorney, Peter A. Prevas, in connection with a Change of Officers Transfer Application. The purpose of the application is to remove Spiros Korologos from the license and add Mohammed Jadoo, Vice President. Stock ownership has changed and Trantafillos Korologos (who was not a license holder) no longer has an interest in the business. Ioannis Korlogos now holds 40% of the stock, Mr. Tsirlis holds 10%, and Mr. Jadoo holds 50% of the stock in the corporation. Mr. Tsirlis will continue to serve as the responsible operator for the business. Mr. Jadoo has been in contact with Inspector Colburn to schedule the licensee test. A state tax release was received allowing the hearing to take place today, however, the State still has a hold in place for renewal. This will have to be resolved by April 29 for the license to be released. This approval would be made effective as of May 1, 2022, to eliminate the need for a renewal to be filed. Motion was made and seconded to approve the application contingent on Mr. Jadoo passing the licensee test and receipt of a State tax release; the vote was unanimous.

## SHOW CAUSE HEARING -

- 1) Rainbow King, Inc. T/A Rainbow King Alcohol Awareness
  Wei Rong Jiang, President, Rainbow King, Inc. T/A Rainbow King, 554 Baltimore Pike, Bel Air, appeared in proper person in connection with a show cause hearing indicating violation of
  - A. Alcoholic Beverages Article ("AB") § 4-505(f) and § 22-1903 of the Annotated Code of Maryland ("Code") as well as Board Rule 3:14 - failure of an individual certified by a state-approved alcohol awareness program to be present on the licensed premises during the hours in which alcoholic beverages may be sold, which individual shall be the license holder or an individual designated by the license holder who is employed in a supervisory capacity.

The violation is alleged to have occurred on February 22, 2022.

Subsequent to the Hearing, the Board considered all the evidence presented. Based upon the statement of facts (i.e. the written report of Board Inspector William Colburn), as well as applicable License Holder testimony, and with further consideration to License Holder's relevant past record (if any) motion was made and duly seconded to find License Holder in violation of Alcoholic Beverages Article (AB) § 4-505(f) and § 22-1903 and Board Rule 3:14 - failure of an individual certified by a state-approved alcohol awareness program to be present on the licensed premises during the hours in which alcoholic beverages may be sold, which individual shall be the license holder or an individual designated by the license holder who is employed in a supervisory capacity. Motion was made and duly seconded to find License Holder in violation; the vote was unanimous. Motion was made and duly seconded to impose a fine of \$500.00; the vote was unanimous.

2) <u>Uncle's Hawaiian Grindz, L.L.C. T/A Uncle's Hawaiian Grindz – Sale to Underage</u>
Kosmas Koukoulis, Jr., Member, Uncle's Hawaiian Grindz, L.L.C. T/A Uncle's Hawaiian Grindz, 2315 Bel Air Road, Suite 2B, Fallston, appeared in proper person in connection with a show cause hearing indicating violation of

A. Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01.

The violation is alleged to have occurred on February 11, 2022.

Kosmas Koukoulis, License Holder, had previously agreed that the cadet and deputy could be excused from appearing today. Discussion was held concerning due process and if it was indeed necessary for the deputy and cadet to be present. Commissioners Burdette and Welch and Chair Majewski agreed that the hearing would proceed without the officers' presence. After Inspector Colburn read the violation report into the record, Ms. Finneran indicated that the last sentence of the violation report should be stricken ("This failure constitutes violations of Board Rule 4:01 and AB § 6-304.").

Subsequent to the Hearing, the Board considered all the evidence presented. Based upon the statement of facts (i.e. the written report of Board Inspector William Colburn), as well as applicable License Holder testimony, and with further consideration to License Holder's relevant past record (if any) motion was made and duly seconded to find License Holder in violation of Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01-Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years. Motion was made and duly seconded to find License Holder in violation; the vote was unanimous. Motion was made and duly seconded to impose a fine of \$1,000.00; the vote was unanimous.
