Motion was made to approve the application and was seconded; the vote was unanimous.

Motion was made and seconded to approve the three applications; the vote was unanimous.

3) STATIO, L.L.C. T/A Market Street Brewery - New License

Andrew Chabalowski, Managing Member, Wilbur W. Bolton, III, Managing Member, STATIO, L.L.C., T/A Market Street Brewery, 203 Market Street, Suite 110, Havre de Grace, appeared in proper person in connection with an Application for a Class DBR – On Sale Only License. Mr. Bolton holds 51% interest in the L.LC. and Mr. Chabalowski holds 49% interest. Mr. Chabalowski has passed the licensee test and will serve as the Responsible Operator. Motion was made and seconded to approve the application; the vote was unanimous.

4) Ziller, L.L.C. T/A Abbey Burger - Supplemental Application

Harry Miller, Managing Member, Marigot Miller, Managing Member, Jason Zink, Member, Tracy McCoy-Soper, Member, Ziller, L.L.C. T/A Abbey Burger, 226 N. Washington Street, Havre de Grace, appeared along with their attorney, Stephan W. Fogleman, in connection with a Supplemental Application. The purpose of the application is to add Tracy McCoy-Soper to the license. Interest in the L.L.C. is held as follows: Harry Miller, 28%; Marigot Miller,

29%; Jason Zink, 33%; and Tracy McCoy-Soper, 10%. Ms. Soper has taken and passed the licensee test and will replace Mr. Zink as the Responsible Operator. Motion was made and seconded to approve the application; the vote was unanimous.

5) D&M's Tiki Bar & Crab Deck, L.L.C. T/A D&M's Tiki Bar & Crab Deck - Transfer

Melissa Vaughn, D&M's Tiki Bar & Crab Deck, L.L.C. T/A D&M's Tiki Bar & Crab Deck, 2207 Pulaski Highway, Edgewood, appeared in connection with a Transfer Application. The license is transferring from Johanna Chicas, Deck Seafood & Tiki Bar, L.L.C. T/A The Deck. Ms. Vaughn holds 100% interest in the L.L.C. She has passed the licensee test and will serve as the Responsible Operator. Remaining outstanding items must be presented before release of the license:

- (1) Copy of Food License issued by the Health Department
- (2) Proof of Settlement (i.e., signed bill of sale and/or settlement statement)
- (3) Copies of any final payments made at settlement

Motion was made and seconded to approve the Transfer Application contingent upon receipt of the three outstanding items; the vote was unanimous.
