1) First-Time Applicants – Knights of Columbus Council #2002 St. Joan of Arc – B&W 02/28 First-time applicants, Anthony Rasa and Mathias Andrulewicz, appeared on behalf of Knights of Columbus Council #2002 in connection with a per diem beer and wine application to be used at St. Joan of Arc for a fundraising dinner on February 18. Motion was made by Commissioner Goddard and seconded by Commissioner Welch to approve the application; the vote was unanimous.

## 2) Longobardi, L.L.C., T/A Garibaldi's Italian Pizza & Grill - New License

Roberto Longobardi, Member, Longobardi, L.L.C., T/A Garibaldi's Italian Pizza & Grill, 686 Bel Air Road, Bel Air, appeared along with his attorney Stephan W. Fogleman in connection with an application for a new Class B1-BW-On Sale Only License. Mr. Longobardi is the sole member holds 100% interest in the L.L.C. and he will serve as the Responsible Operator. The only outstanding item is the licensee test. Once applicant passes the test, the license can be issued. #### ADMINISTRATIVE BUSINESS

 Pappas Bel Air, L.L.C., T/A Pappas Restaurant & Sports Bar - 3<sup>rd</sup> 60-Day Update & Request for Tentative Approval Extension Joseph F. Snee, Jr., attorney for Pappas Bel Air, L.L.C., has submitted a 60-day status update. The inside of the building is reaching completion and the projected opening is late February 2023. Mr. Snee has requested an additional six months of tentative approval to run through August 20, 2023, to complete the buildout and open for business. Outside seating area has encountered construction delays; construction will continue and be completed after the opening of the restaurant. Motion was made by Commissioner Welch and seconded by Commissioner Goddard to approve the tentative approval extension through August 20; the vote was unanimous.

## STAFF REPORT / PUBLIC COMMENT / BOARD COMMENT

Mr. Crabbs reported that staff has met with three vendors to replace the Konica copier and Modus Solutions appears to be the best fit with a cost lock in for six years at \$615 per month to include maintenance and toner for a Canon MFD and toner for four HP desktop printers.

The HCLCB supports the "quota" change from 3,000 to 4,000, which will reduce the total number of available Class "A" licenses to 12, based on the most recent Harford County population figures.
