McLauchlin who then contacted HCLCB staff to advise that license holder would waive her right to appeal if she could serve the suspension on August 25 and Chair Goddard agreed in writing. Later it was confirmed that Coakley's Pub would be closed for vacation from August 21 through August 30. Chair Goddard revised the decision letter to advise that the suspension would be served September 15.

#### 5) Budget 2023-2024

GM Crabbs suggested that he could work a four day week as a cost saving effort. He has agreed to forego any salary increase if Inspector Buchler is hired full time and a part time inspector is hired; Commissioner Walters will revise the budget for discussion at the next meeting.
