1) Meeting with County Officials

GM Crabbs reported that he and Chair Goddard met with County Executive Cassilly, Chief of Executive Staff Joe Cluster, Director of Administration Rob McCord, Delegate Teresa Reilly, and Senator Jason Gallion to discuss options based on the legislative review of our budget. The County has offered to explore the possibility of leasing a vehicle through the County, the County would cover the maintenance, and fuel could be purchased from the County. Other topics that were discussed will be presented when all commissioners are present.

Michael Scheuerman, license holder at Friendship Wine & Liquor, had a fundraiser for the County Executive at Silver Spring Mining Company after the HCLCB's meeting with Mr. Cassilly and indications were that the meeting with HCLCB and legislative representatives went well.

There was discussion in connection with the proposed legislation to revise the Performing Arts Theater License. Commissioner Majewski discussed building a relationship with the Office of Drug Control Policy particularly in connection with Overdose Awareness Month and perhaps requesting licensed establishments to advertise "mocktails" for the month. Commissioner Majewski suggested to the Office of Drug Control Policy that they reach out to HCLCB.

GM Crabbs advised that there are several candidates interested in the PT inspector position with a target January start date.

There being no further business, motion was made by Commissioner Majewski and was seconded to adjourn the meeting; the vote was unanimous.
