#### **BOARD MEETING MINUTES**

September 24, 2025

#### CALL MEETING TO ORDER

A regular meeting of the Liquor Control Board for Harford County was called to order at 9:00 a.m. by Chair Goddard at the Board's office. In attendance were Commissioners Sines, Walters, and Miller, GM Crabbs, and Board Counsel Finneran. Vice Chair Majewski was excused.

## 1) First-time Applicants - Humane Society of Harford County - 10/05 B&W

First-time applicants Amanda Hickman and Erin Long appeared on behalf of the Humane Society of Harford County in connection with a per diem beer and wine application for a "goat yoga" fundraising event to be held on October 5 in the Humane Society's barn. Motion was made by Commissioner Sines and was seconded to approve the application; the vote was unanimous.

## 2) First-time Applicants - HDG Masonic Building Preservation Foundation - 10/11 B&W

First-time applicants Phillip Powell and Al Peteraf appeared on behalf of the HDG Masonic Building Preservation Foundation in connection with a per diem beer and wine application for the HDG Oktoberfest on October 11 at Concord Point Park. Motion was made by Commissioner Walters and was seconded to approve the application; the vote was unanimous.

Application for beer, wine, and liquor has also been submitted for the Maryland State BBQ Bash being held on October 11 and 12. Motion was made by Commissioner Walters and was seconded to approve the application; the vote was unanimous.

First-time applicants Stephanie Kennedy and Sydney Younge appeared on behalf of Steppingstone Farm Museum in connection with an application for beer and wine for their Fall Harvest Festival being held on October 11. Motion was made by Commissioner Miller and was seconded to approve the application; the vote was unanimous.

## 1) TCL Properties, L.L.C. T/A Wine World Beer & Spirits

Carmelo Labruto, Managing Member, Viola King, Member, TCL Properties, L.L.C. T/A Wine World Beer & Spirits, 406-A Constant Friendship Blvd., Abingdon, appeared in proper person in connection with violation of the following:

CHARGE 1: Board Rule 4:01, MINORS, (a)(b) and (c) which states:

- (a) A license holder or an employee of a license holder may not sell or provide alcoholic beverages to an individual under the age of 21 years.
- (b) A license holder, a proprietor, or an operator of an establishment that provides alcoholic beverages may not allow on-premises consumption or possession of alcoholic beverages by an individual under the age of 21 years, regardless of who purchased or obtained the alcoholic beverages.
- (c) A license holder or an employee of a license holder shall be fully responsible for determining that the individual to whom alcoholic beverages is sold is over the age of 21 years; and every license holder or employee of a license holder shall have the right to refuse the sale of alcoholic beverages to any individual who does not provide sufficient proof of legal age to the satisfaction of the license holder or employee of a license holder.

Minas Hatziminas, Member, Nick Hatzinicolas, Member, TCL Venetian Haco, L.L.C. T/A Venetian Italian Eatery, 1901 Tree Top Drive, Edgewood, appeared in proper person in connection with violation of the following:

CHARGE 1: Board Rule 4:01, MINORS, (a)(b) and (c) which states:

- (a) A license holder or an employee of a license holder may not sell or provide alcoholic beverages to an individual under the age of 21 years.
- (b) A license holder, a proprietor, or an operator of an establishment that provides alcoholic beverages may not allow on-premises consumption or possession of alcoholic beverages by an individual under the age of 21 years, regardless of who purchased or obtained the alcoholic beverages.

#### 3) Burgology of Bel Air, L.L.C. T/A Sol Oaxaca

Robert F. Dubell, III, Member, Burgology of Bel Air, L.L.C. T/A Sol Oaxaca, 16-A Bel Air South Parkway, Bel Air, appeared in proper person along with manager Thomas Doxanas, in connection with violation of the following:

CHARGE 1: Failure to comply with Alcohol Awareness certification requirement, in violation of Md. Code Ann., Alcoholic Beverages & Cannabis Article, Sections 4-505(f) and 22-1903 ("Code") and Board Rule ("BR") 3:14 (a)(c).

The alleged violation occurred on June 12, 2025.

Subsequent to the hearing, the Board considered all the evidence presented. Based upon the statement of facts (i.e., the written report of Chief Inspector Daniel Buchler), as well as applicable License Holder's testimony and with further consideration to License Holder's relevant past record (if any), the Board made the following finding:

On Charge 1, motion was made by Commissioner Walters and was seconded to find License Holder in violation; the vote was unanimous. Motion was made by Commissioner Walters and was seconded to impose a fine in the amount of \$100.00; the vote was unanimous. Additionally, as license holder Robert Frankis, Member, failed to appear for the hearing, motion was made by Commissioner Walters and was seconded to impose a fine in the amount of \$250.00; the vote was unanimous.

### 4) QSA Foods Corporation T/A All American Steak House

Daniel Santoro, President, QSA Foods Corporation T/A All American Steak House, 3720 Churchville Road, Building B, Aberdeen, appeared in proper person in connection with violation of the following:

CHARGE 1: Board Rule 4:01, MINORS, (a)(b) and (c) which states:

- (a) A license holder or an employee of a license holder may not sell or provide alcoholic beverages to an individual under the age of 21 years.
- (b) A license holder, a proprietor, or an operator of an establishment that provides alcoholic beverages may not allow on-premises consumption or possession of alcoholic beverages by an individual under the age of 21 years, regardless of who purchased or obtained the alcoholic beverages.
- (c) A license holder or an employee of a license holder shall be fully responsible for determining that the individual to whom alcoholic beverages is sold is over the age of 21 years; and every license holder or employee of a license holder shall have the right to refuse the sale of alcoholic beverages to any individual who does not provide sufficient proof of legal age to the satisfaction of the license holder or employee of a license holder.

On Charge 1, motion was made by Commissioner Miller and was seconded to find License Holder in violation; the vote was unanimous. Motion was made by Commissioner Miller and was seconded to impose a fine in the amount of \$2,000.00; the vote was unanimous.

#### 5) Chile Fiesta, Inc. T/A La Tolteca

This hearing will be rescheduled; Alfonso Martinez appeared, however, three other license holders did not appear for the hearing.

#### **ADMINISTRATIVE BUSINESS**

#### 1) Paper Shredding Vendor

The administrative staff reports that the Board has employed three paper shredding vendors over the years, and only one vendor has performed satisfactorily. The commissioners agreed to return to Chesapeak Shredding for shredding needs.

Mike Scheuerman, license holder at Friendship Wine & Liquor, reported on the various obstacles dealing with the County zoning and permitting process for Friendship Park.
